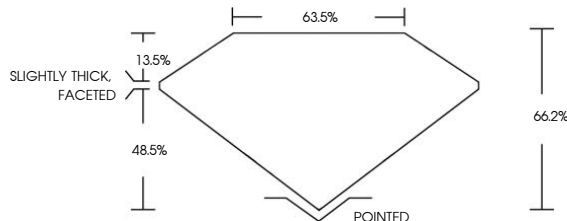

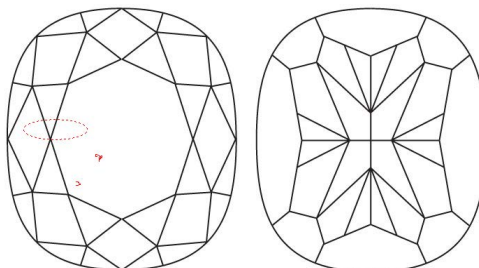

In the case where diamond melee is set in a mounting, a random testing procedure, regarding the diamonds being of natural or laboratory created origin will be performed.
